4	Confirmation whether the contracting partner will provide the services directly or will work with sub-contractors, If the latter option, please provide the details (copies of registration certificates, business license, and TIN certificates) of the sub-contractors you will work with.
5	Names and summary CVs of your company's (or sub-contractors) key personnel to demonstrate the capability to carry out the work.
6	Demonstrate access to various equipment and machinery needed to carry out the services.
7	Provided details of the Bidder's physical premises within Ethiopia and contact details.
8	Audited Financial Statements for the past three consecutive financial years.
