- The Digital Document Management System proposed by the supplier must outline the creation, storage, categorizing, metadata tagging, delivery or sharing, repurposing, review and reporting, archiving and / or destruction of all digitally stored documents. Where applicable this should also entail the management of manual documents stored by the Supplier.
