- Confirmation whether the contracting partner will provide the services directly or will work with sub-contractors. If the latter option, please share the details of the sub-contractors you will work with
- Proof that you have the necessary regulatory approvals to provide such services in Ethiopia
- Duly Completed statement of compliance (fully compliant, partially compliant, and non-compliance) to each of the below-listed requirements.
- Provide a company profile outlining your capabilities, human talent, skills, and capacity to offer the service.

- Prequalification of shortlisted suppliers
- Issuing of 'Request for Proposal' to prequalified suppliers

- Only the suppliers who meet our minimum requirements will be considered for further discussions.
- No prices should be provided with this EOI.
- The receipt of response shall not bind Safaricom to any contractual agreements with the prospective bidder. Such arrangements shall only come in place once a tender process has been completed and an award issued to a successful bidder after technical and commercial evaluation.
- Any costs associated with the preparation and submission of the response to the EOI shall be borne by the EOI respondent.
