



EXPRESSION OF INTEREST FOR THE PROVISION OF FUEL TRANSPORTATION SERVICE (POSTED FOR THE SECOND TIME)

Safaricom Ethiopia is seeking the services of a supplier/s who will be able to provide the fuel transportation service for different locations within Addis Ababa. The service provider/s are required only to handle the transportation service from the nearby designated fuel stations to a named location.

EOI REQUIREMENTS

Interested and capable service providers may submit their Expression of Interest by providing the information and documents listed below:

- Provide a company profile outlining your capabilities and a list of drivers and ownership certificates.
- At least three suitable client references (preferable in the service industry) for the provision of similar services in the Ethiopian Market
- Confirm whether the contracting partner will provide the services directly or will work with sub-contractors. If the latter option, please share the details of the sub-contractors you will work with
- Proof of the necessary regulatory approvals to provide such services in Ethiopia
- Duly Completed statement of compliance (fully compliant, partially compliant, and non-compliance) to each of the below-listed requirements.

- No prices should be provided with this EOI.
- The receipt of the response shall not bind Safaricom to any contractual agreements with the prospective bidder. Such arrangements shall only come in place once a tender process has been completed and an award issued to a successful bidder after technical and commercial evaluation.
- Any costs associated with the preparation and submission of the response to the EOI shall be borne by the EOI respondent.
