



## EXPRESSION OF INTEREST (EOI) FOR THE PROVISION OF CORPORATE GARBAGE COLLECTION AND WASTE MANAGEMENT SERVICES

### INTRODUCTION

#### DESCRIPTION OF REQUIREMENTS

Safaricom Ethiopia requires the services of a qualified and experienced Contractor for the provision of various Solid Waste Management Services which include Safaricom Ethiopia multiple corporate offices, multiple warehouses, multiple datacenter, and Shops as per the agreed schedule and/or “as and when” required emergency on-call services. The successful Contractor shall provide all supervisory personnel, management, manpower, equipment, tools, materials, and other resources to plan, prepare, and execute the services that are required to all designated Safaricom Ethiopia locations.

The Waste Management Services shall include a minimum of the following:

- I. Collection of solid waste (segregated and non-segregated) from four (4) Safaricom Collection Areas Namely multiple Data center, Warehouses, Shops, and Safaricom Ethiopia multiple corporate offices.
- II. Transportation of segregated solid waste to designated facilities, and non-segregated solid waste to sorting facilities (or dumpsites with sorting facilities) as applicable, in a manner that does not harm the environment, in accordance with the standards and conditions set by and subject to approval of Ethiopian Environment, forest, and climate change commission
- III. Segregation of waste into recyclables and non-recyclables at designated sorting facilities or at the dumpsite level
- IV. Transport recovered recyclables to designated recycling facilities for further recycling.
- V. Dispose-off non-recyclable rejected waste to landfills/ dumpsites in a manner that does not harm the environment, in accordance with the standards and conditions set by Ethiopian Environment, forest, and climate change commission
- VI. Cleaning/Scrubbing and disinfection of dumpsters/bins.
- VII. Weighing of wastes and booked in the datasheet
- VIII. Measure and report the wastes that are collected, Recycled, and Disposed of monthly in every sites.
- IX. Be open for any time visit, internal and external audit, and reporting.

Safaricom Ethiopia intends to enter a Contract for an initial two (2) years period with the option to extend at the discretion of Safaricom, subject to satisfactory performance by the Contractor.

For the purpose of establishing a contract, Safaricom will undertake a competitive bidding exercise in the future and consider inviting those companies that have expressed their interest and provided initial relevant information as to their ability to fulfill Safaricom's requirement.

Please note, that this is not an invitation for submission of a price proposal.

Once the responses are received the further process will follow the steps below:

- Prequalification of shortlisted suppliers
- Issuing of tender to prequalified suppliers

#### NOTE:

- Only the suppliers who meet our minimum requirements will be considered for further discussions.
- No prices should be provided with this EOI.
- The receipt of response shall not bind Safaricom to any contractual agreements with the prospective bidder. Such arrangements shall only come in place once an award has been issued to a successful bidder after a tender process.
- Any costs associated with the preparation and submission of the response to the EOI shall be borne by the EOI respondent.

#### NOTE:

Safaricom reserves, at its sole discretion, the right to select or reject, either in totality or partially, any or all proposals made in the context of this EOI. Any such decisions made will be final and no correspondence will be engaged in, other than to inform the bidders of the outcome of the process.
