

EXPRESSION OF INTEREST (EOI) FOR THE PROVISION OF THE STORAGE, RETRIEVAL, AND SCANNING OF DOCUMENTS

Safaricom Ethiopia is seeking the services of a supplier who will be able to deliver the storage, retrieval, and scanning of documents. We thus seek to engage suitable partners who can provide the following services in terms of document management:

SERVICES REQUIRED:

- Documents will be packed and indexed by the supplier in standard storage boxes or files supplied by the supplier
- Agrees and undertakes that it will not pack or store flammable items in the storage boxes or any items other than standard paper documentation and/or electronic media
- Agrees and undertakes that it will not store nor convert any documentation and
 or other items that of which may be held or could be held to be contrary to any
 legislation, authority, by-law, common law, regulations, etc. In the event that the
 Supplier should learn that such items or documents stored by the customer are
 unlawful, or may become unlawful, the Supplier shall then be entitled to take all
 reasonable measures and steps that may be necessary to comply with any such
 aforementioned laws
- Agrees and undertakes that it will abide by all reasonable procedures, requirements, and stipulations of the Supplier relating to the packing, depositing, and retrieving of any documents and or electronic media stored
- Ensure that all documents, boxes, and other items supplied by the customer to be stored at the suppliers' premises are reasonably protected against the risk of fire and damage by any other means and take reasonable precautions against the damage and destruction of the documents
- Allow Safaricom Ethiopia, subject to compliance with reasonable security arrangements stipulated by the Supplier to have reasonable access to items stored by the customer on normal business days and during normal business hours
- Ensure that it stores documents archived in standard archive boxes until such time it is requested for destruction or expiry of the contract.
- Ensure that documents are retrieved from the boxes in storage as and when
 requested by Safaricom Ethiopia in writing by an authorized official. This
 would entail the Supplier will have the physical document delivered or emailed
 electronically depending on Safaricom Ethiopia's requirements.
- Ensure that all documents delivered to the Supplier will be electronically scanned by the Supplier for retrieval by Safaricom Ethiopia as and when needed.
- Ensure that documents are collected from Safaricom premises at predetermined and agreed-upon time frames

EOI REQUIREMENTS

Interested and capable service providers may submit their Expression of Interest by providing the information and documents listed below:

- At least two suitable client references (preferably telecommunication) for the provision of similar services in the Ethiopian Market
- Confirmation whether a contracting partner will provide the services directly or will work with sub-contractors, If the latter option, please share the details of the sub-contractors you will work with
- Proof that you have the necessary regulatory approvals to provide such services in Ethiopia
- Provide a company profile outlining the capabilities and services you deliver

- Duly Completed statement of compliance (fully compliant/ partially compliant and non-compliance) to each of the below-listed requirements.

 after technical and commercial evaluation.
- Any costs associated with the preparation and submission of the response to the EOI shall be borne by the EOI respondent.
